### **Fundamentals of Unarmed (Teen)**

Students will learn the basics of unarmed combat including but not limited to slaps, falls, punches, and kicks. Students will be taught how to safely and effectively use these techniques in fight choreography with a short phrase to be performed at the end of the class.

### **Fundamentals of Single Sword**

Students will be instructed in the SAFD fundamental techniques of Single Sword including but not limited to cuts, thrusts, parries and footwork.

### **Fundamentals of Knife**

Students will be instructed in the SAFD fundamental techniques of Knife including but not limited to cuts, blocks, checks, and hook.

### **A Matter of Knife of Death**

After learning fundamental knife technique, students will be tasked in exploring intention and the acting of the fight through a game and partner work.

### **Fundamentals of Quarterstaff**

Students will be instructed in the SAFD fundamental techniques of Quarterstaff including but not limited attacks and defense in both short form and long form, exploring rhythm, and combining it all with footwork.

### **Creature Combat**

In this stage combat class, students will first learn a short, dynamic fight sequence using swords. Then, through guided movement exploration, they'll embody a fantasy creature: orc, goblin, troll, or something of their own imagination and discover how it moves, stalks, and attacks. Finally, they'll

bring their monstrous forms to life in battle, exaggerating their choices to create bold, theatrical fights.

**Combat Instructor:** Will Snyder

Will is a ***Society of American Fight Directors (SAFD)*** certified teacher. He has been active as a stage combat actor, teacher, and choreographer for over 15 years. His certification includes **all eight SAFD weapon disciplines**; unarmed, rapier & dagger, single sword, broadsword, broadsword and shield, smallsword, quarterstaff, and knife. He lives locally and is the founder of BattleKat Combat specializing in fight choreography and stage combat workshops for Chattanooga and it's surrounding areas.
